We collect a variety of information as needed to operate our business, to provide products and services to you, and for the legitimate interest of our business, including for marketing purposes, to the extent permitted by applicable law. The legal basis for using your personal information includes:

- Legitimate interest

Use of "Cookies":

IP Address:

An IP address is a number used by your computer every time you connect to the internet. IP addresses are automatically collected by our web server as part of general demographic data known as "traffic data".

- or other relevant and applicable information.

When processing payments, if applicable, we DO NOT collect or store any payment details, specifically credit card numbers, on our website. What do we use your information for?

SSL Technology
